Frequently Asked Questions

Why is there a one-year commitment?

A commitment to BTI360 is necessary to submit you for a U.S. Government security clearance. We also take our investment into our college hire teammates very seriously. We put a lot of time, energy, and resources into this program to make sure you develop the skills to succeed as a professional software engineer. Since we invest in and are committed to you, we ask that you make a commitment to us.

To make this decision easier, in addition to the offer for the summer internship, you will also receive an offer for full time employment with BTI360, including your minimum starting salary. Still have questions? Just ask our previous college hires for yourself during our interview process.

Why would someone coming out of college want to work with BTI360?

College begins to prepare you for a career in the real world, but your development doesn't stop there. To stay relevant, you have to continue learning and expanding your skills. What is the value of a security clearance?

Not to mention, there's a high demand for software engineers with a security clearance—and that means added job security.

What does it mean to be a government contractor?

A government contractor is someone who is contracted out to work directly for the government or for a prime contractor that owns a government contract. A contractor works at a government or prime facility along with contractors from other companies.

Where is the internship located?

The internship is located at BTI360's headquarters in Ashburn, VA, outside of Washington, DC.

Where will I be working when I come on full time with BTI360?

A majority of BTI360's work is located in the Northern Virginia area along the Dulles Technology Corridor including Tyson's, McLean, Reston, Herndon, and Chantilly.

Is there any relocation or housing compensation?

Housing costs have been factored into the internship's hourly rate. However, we will consider relocation and/or housing compensation on a case-by-case basis for those in need. If you are not from the Northern Virginia area, we'll help you find summer housing. Just ask.

What kind of work will I be doing during the internship?

You will build an application from start to finish using cutting-edge software development tools and techniques. Some of the technologies that have been used in past years are Java, Kotlin, Spring Boot, Angular, Kubernetes, Solr, and Amazon Web Services. You will also use industry best practices for software engineering such as scrum, kanban, pair programming, automated testing, and test-driven development.
